

CINCINNATI PARK BOARD
BURNET WOODS PARKING PERMIT INFORMATION

1. Two hundred seventy three (273) on-street parking spaces in Burnet Woods have been designated for long-term parking. Vehicles with current Cincinnati Park Board parking permits are permitted to park in designated spaces.
2. One hundred fourteen (114) two hour parking spaces in Burnet Woods have been designated for park visitors' (including handicapped parking) use only. These two-hour parking areas are free (no permit is required) and are located closest to areas used by the public.
3. Vehicles parked in parking permit areas must display valid parking permits on interior rear view mirrors during enforcement periods, Monday through Friday, 6:00 a.m. - 10:00 p.m.
4. All parking spaces are available on a first come basis; purchase of a permit does not guarantee a parking space.
5. Permit holders park their vehicles in permit areas at their own risk of fire, theft or damage to their vehicle.
6. Annual permits and quarterly permits can be purchased at the Park Visitor Center located in Krohn Conservatory in Eden Park (1501 Eden Park Drive): \$125 per quarter / \$350 annual permit. **NO REFUNDS.**
7. Failure to display a valid permit during enforcement periods, unauthorized parking in other areas of Burnet Woods and/or noncompliance with other applicable rules and regulations of the City of Cincinnati Traffic Code will result in a citation.

PERMIT HOLDERS RECEIVING CITATIONS SHOULD CONTACT THE CINCINNATI POLICE DIVISION'S PARK UNIT AT 352-4088 IF FURTHER INFORMATION IS NEEDED.

8. Revenue from parking permit sales is designated to help support the maintenance and preservation needs of Cincinnati's parks.
